The Temporary Youth Leader role

Our Temporary Youth Leader role is to lead the delivery of the 3CV youth vision, building upon what is in place currently and partnering with God, the 3CV leadership team, volunteers and other youth workers and organisations to achieve this.

Our vision for our youth work is:

- ➤ **Discipleship** Helping young people in the 3CV community to be disciples, make disciples, grapple with difficult subjects, learn by doing and use the Bible to help guide them.
- ➤ **Encounter** Providing opportunities for young people in the 3CV community to encounter God through Jesus and the Holy Spirit, the gifts of the Holy Spirit, the power of the Bible and be naturally supernatural daily.
- ➤ **Fun, belonging and welcoming.** Ensuring all the youth groups / events run by 3CV are always open and welcoming to new people, fun, social and create a sense of belonging for all those who come along.
- ➤ **Seamless transition and growth.** For the youth work to be an integrated part of a bigger 0 18+ 3CV programme that helps provide seamless development, transition and opportunities for spiritual and numerical growth as children grow up in 3CV and invite their friends to come and experience what they have.

This role requires a Spirit filled, self-motivated individual with a passion and a love for God and young people. We would like them to have skills in team building, communication and administration, a solid knowledge of the Bible and the ability to engage, build great relationships and disciple young people from both within and outside of the Church.

The individual must be in sympathy with, and become clearly committed to, the church and its vision and become actively involved in the church beyond this position.

terminate on 5th May 2025 or upon the return of the employee on maternity leave if earlier. Actual hours / days of work may vary from week to week and will include evening and weekend work.

Your salary for the contracted period will be £18,928 (equivalent to approx. £27,000 per annum for a full time role), paid on a monthly basis. No overtime pay is provided. Based on a 28 hour working week your holiday entitlement for the contracted period will be 94 hours including bank and public holidays, to be taken at such time or times as may be agreed with your line manager. The holiday year runs from 1st January to 31 December every year.

Location of work: Your normal place of work will be 3 Counties Vineyard, Linchmere Road, Haslemere, Surrey. GU27 3QW, however administration can be conducted from home. The job holder will be required to travel, predominantly locally, to other premises where youth / church events may be held. Mileage can be paid for any work travel that exceeds normal travel requirements outside the Haslemere area.

Purpose of the Temporary Youth Leader role:

Building upon what is in place currently, to lead and oversee the youth ministry at 3CV, working alongside key staff members and a team of volunteers, delivering our weekly activities and one-off events. The role also includes the opportunity to further develop and grow the youth work at 3CV while modelling a kingdom lifestyle.

Overall responsibilities

- To lead, plan and develop the youth ministry at 3CV through a team of volunteers and liaising
 with key staff members and the leadership team. This includes identifying, recruiting, training,
 deploying and monitoring youth team members as well as all the admin and scheduling of
 activities.
- To build relationships with the young people in church and in the wider community.
- To be responsible for the communication to young people and their parents / carers regarding youth activities, whilst ensuring data protection requirements are adhered to. To utilise our ChurchSuite database and appropriate electronic communication tools to achieve this.
- To ensure all activities meet safeguarding requirements.
- To preach and teach at youth events, all age services as required.

Specific Youth Responsibilities

- To lead, plan, develop and/or oversee the current regular weekly activities at the 3CV, with a team of volunteers, currently including:
 - Sunday morning Lava: Years 6 8
 - Sunday morning Fusion: Years 9 -13
 - Sunday evening Fusion After Hours: Years 9 -13
 - Tuesday evening Lava Late: Years 6 8
 - Wednesday evening Youth discipleship: Years 7 13
- To lead, plan and deliver one-off events including:
 - DTI roadtrips
 - DTI summer camp
 - Holidav club
 - Sleepovers / BBQ / end of term specials / Light parties
- To pray for and ensure the pastoral care and spiritual nurture and development of the young people in 3CV.
- To help the young adults moving onto university, apprentices and work places to stay connected and cared for.
- To provide training, development and encouragement for young people in groups and 1 to 1 mentoring to grow in:
 - Self-awareness and identity as children of God
 - Discipleship in the word of God,
 - Spiritual formation in building their own relationship with God.
